We would have to buy by tray. Orders must be in by end of February to the SE PA chapter. Someone would have to coordinate orders, have orders delivered and then distribute to membership.  - a. MD passed law stating that HOA's cannot ban the planting of native plants
 - b. HB 797 Native Vegetation Along Pennsylvania's Highways still in Rules committee. The bill calls for planting of native vegetation along highways. The group discussed support for the bill but also wanting to see broader support for the planting of natives, much like the Maryland bill.
